Q -Do all projects (including RRH projects) need to complete the Chronically Homeless questions?

A- Yes. Not only is this the base-line for most of our reports (like how many people experience homelessness in geographical areas, but this is also a HUD mandated questions for all CoC and ESG projects as well as many other federally funded projects.

Q - Is there a place to indicate the person(s) are NOT chronically homeless?

A- All projects are required to collect the Prior Living Situation, Length of Stay, Approximate date homelessness started, number of times and number of months homeless questions in HMIS. Depending on the project type and how the Prior Living Situation is answered, a project may not have to answer approx. date homeless started, number of times and months homeless though.
